## ORDINANCE AMENDING ARTICLE 4 SECTION 162 DESIGN STANDARDS #3 AND ARTICLE 8 SECTION 212 SITE PLAN REVIEW OF THE LAND DEVELOPMENT CODE, CODE OF ORDINANCES OF THE CITY OF OXFORD, MISSISSIPPI

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF OXFORD, MISSISSIPPI AS FOLLOWS:

**SECTION I.** That Article 4, Section 162 Design Standards of the Land Development Code, Code of Ordinances, Oxford, Mississippi, is hereby amended to read as follows:

Sec. 162.04 - Design Standards.



162.04. # 3 a. Number of access points. Residential developments with twenty (20) or more lots or dwelling units shall have a least two separate points of access. However, residential developments with fifty (50) or less lots or dwelling units may have a single access point with an approved stub street.

**SECTION II** That Article 8, Section 212 Site Plan Review of the Land Development Code, Code of Ordinances, Oxford, Mississippi, is hereby amended to read as follows:

<u>Sec.212.04</u> - Conditions and general considerations on issuance of site plan approval.

212.04 # 11. Number of access points. Residential developments with more than fifty (50) dwelling units and more than 117 bedrooms shall have a least two separate points of access. Residential developments with one hundred (100) or less dwelling units and less than 233 bedrooms may have a single access point if all buildings are equipped with approved automatic sprinkler systems. Residential developments with one hundred and fifty (150) or less dwelling units and less than 350 bedrooms may have a single point of access if all buildings are equipped with approved automatic sprinkler systems and the development provides storm shelter for at least 50% of the maximum number of residents permitted within the development and has an emergency management plan. The shelter design and emergency plan shall be approved by the City of Oxford Emergency Manager. (used 2.33 bedrooms per unit)

## **SECTION III. REPEALING CLAUSE**

All ordinances or parts of ordinances in conflict herein shall be, and the same are hereby repealed.

## **SECTION IV. EFFECTIVE DATE**

All ordinances shall take effect and be in force as provided by law.
