a. Building and Grounds

Update on Status and Timeline for FY25 Projects Tree Plans and Planting:

Commissioner Hunter discussed with the Tree Board that the Old Oxford Police Department Renovations should include partial interior renovation and only painting of the exterior with no tree planting planned at this time.
