# Call to Order

Commissioner Cowan Hunter called the meeting to order at 11:06 AM.

## **Approval of Agenda**

Commissioner Hunter motioned to approve the agenda. Commissioner Hume Bryant seconded the motion. All commissioners voted aye; the motion passed.

#### **Approval of the December 2023 Minutes**

Allison noted a grammar change. Commissioner Hunter motioned to approve the December 2023 Minutes. Commissioner Howorth seconded the motion. All commissioners voted aye; the motion passed. There was discussion regarding the Planning Commission meeting discussed at the previous meeting. Commissioner Hunter recommended the Tree Board watch the Planning Commission meeting.

#### **Departmental Issues and Reports**

## 1. Buildings and Grounds

Greg Pinion, Director of Building and Grounds, was not present. Commissioner Hunter noted he spoke to Greg briefly last week. Commissioner Hunter noted they would be meeting to finalize signage for the Tribute Tree Grove.

a. Public Assistance Requests or Inquiries

b. Tree Planting or Maintenance Update

c. Discuss Possible Volunteer Project for UM Big Event

Commissioner Hunter noted he asked Greg to think about a possible idea for a project for the UM Big Event.

#### 2. Planning

Ben Requet, Director of Planning, was not available.

a. Update re current/pending development tree issues.

Commissioner Hunter indicated he had not heard from Ben, but indicated he planned to reach out to him. Commissioner Hunter once again referred the Tree Board to the Planning Commission or Planning Department regarding the Murfield Meadow Development.

## 3. Engineering/Special Projects

a. Update re Brittany Woods and time frame for FY 24 Projects

He indicated he reached out to Alderwoman Howell – Atkinson of that District as well as the Mayor regarding moving forward with the project. There was discussion. Commissioner Hunter reported he did not have an update regarding Hill Country Roots.

3. Update re MFC and Tree City application

Commissioner Hunter reported Alex indicated the MFC/Tree City Applications evaluation was running behind. There was discussion. Commissioner Hunter indicated he would continue to check with Alex regarding the process to ensure the submitted application is reviewed for Tree City USA.
