1. Call to order.

- 4. Departmental Issues and Reports:
 - a. Buildings & Grounds Department
 - i. Public assistance requests or inquiries

Greg Pinion, Building and Grounds Superintendent, noted the Building and Grounds department received several calls where he had to measure City Right-of-Way and the issues were private. Therefore, Greg indicated there were no reported issues with public trees.

Commissioner Hunter noted he observed the crepe myrtle was removed from this location.

c. General Government-Special Projects Department

i. FY 25 Project Budget Recommendations and Timelines

Commissioner Hunter indicated that Mark Levy, Director of Special Projects, would be discussing the budget recommendations and timelines for the upcoming Fiscal Year 2025. Commissioner Hunter indicated the current funding in the Tree Escrow account should be \$161,000.00. Commissioner Hunter further discussed the Tree Escrow Fund. Commissioner Hunter inquired with Mark regarding what would be utilized during this fiscal year. Mark discussed the Oxford Police Department project, The City Grocery Parking Lot project, and the Oxford Swimming Pool Project. Mark indicated the only new project he added would be the Old Taylor Replacement project. There was discussion regarding the project timelines and budget recommendations. Commissioner Hunter recommended looking further into the projects that would take place in FY 2025 at the next meeting.

ii. Plans and timeline for startup of project reassessments

Mark discussed the different sites he and Greg assessed throughout the City. There was discussion. Matt Nielson inquired regarding irrigation in relation to Old Taylor. There was further discussion. Mark indicated he would like to hear from the Tree Board and Matt regarding recommendations regarding varieties of trees. There was more discussion. Greg discussed utilizing varieties in relation to project areas and Matt referenced the Land Development Code. There was further discussion.

5. Consider new business:

a. Discussion regarding feasibility of easement use in our conservation projects

Commissioner Hunter discussed the topic of conservation easements and indicated he hoped Ben would be present at the next meeting to discuss this topic. Commissioner Bryant discussed conservation in relation to tree canopy. Commissioner Hunter discussed tree conservation in relation to the City as well as what he's read about the use of easements in other places. There was discussion. Commissioner Hunter recommended this be discussed further at a future meeting. There was more discussion. Matt indicated there was a workshop offered through the Mississippi Land Trust and recommended utilizing them as a resource. There was further discussion.

b. Mississippi Forestry Commission Updates

c. Tribute Trees Project Update
