MUNICIPAL COURT TRIAL DOCKET

Please review the docket carefully and address any questions, concerns, or requests for continuance as early as possible. The Motion for Continuance is linked [here](#) for your convenience. All motions must be filed with the Clerk's Office before a continuance will be considered. Please review the [court's continuance policy](#) prior to submission.

Reminder: Any motion for continuance filed after 5:00 p.m. on Friday **must** involve an emergency circumstance and will require the judge's approval.

If you wish to meet with the prosecutor regarding a possible plea, you must do so before the 1:00 p.m. docket call. The prosecutor is available as early as 8:00 a.m. each Wednesday. If you would like to review a case on the Trial Docket with the prosecutor, please notify a clerk so the file can be pulled in advance. If you elect to enter a plea on a case that is set for trial, you must notify the Court Clerk as soon as possible so the trial may be canceled and any witnesses may be released.

Any plea entered after the 1:00 p.m. docket call will be considered an open plea before the Judge. Once the trial docket has been called by the judge, the prosecuting attorney is not required to extend, modify, or negotiate a plea offer.

All parties remaining after the 1:00 p.m. docket call must be prepared to proceed to trial.

Please note:

- Only cases appearing on the docket will be addressed.
- Expungement petitions may be filed in the Clerk's Office and will be processed after court.
- The Clerk's Office will not hold or process orders for cases not listed on the docket.
- Requests to add cases to the plea docket **must** be submitted by 12:00 p.m. on Tuesday.
- **ALL PARTIES MUST BE SEATED IN THE COURTROOM FOR DOCKET CALL.**
